# COMMANDER'S COLUMN

## How's Your Margin Today?

During our January Unit Training Assembly, I spoke with all of you about safety and how I visualize it using the concept of "margin". Margin is the difference between operating safely and having a mishap. A wide safety margin lessens the possibility of having a bad event. It is very useful to determine your personal margin of safety during each waking moment.

As you ponder your own personal margin you will realize that it is dynamic and changes with time. For example, when you first arrive at work, ready to do your job and assuming you had a

restful night's sleep, you have a wider margin than you will have at the end of your 9 hour shift. You may want to schedule more complex or physically demanding tasks at the beginning of a work shift, particularly if you are a supervisor. This is an example of risk management. You are adjusting based on your present margin.

The components of your own personal safety margin are many and you should consider their broad scope. Am I trained to do this task? Am I proficient at it? Am I properly following technical orders and procedures? How is my physical and emotional well being? Since here at the Wing you typically operate as part of a team, you need to know that your teammates are

up also to the many tasks ahead. A key function for all supervisors at all levels is to assess the team's collective margin and make proper adjustments to reduce risk.

This margin concept should also be considered in what we may think of as mundane tasks. I think the best example of this may be driving a vehicle on our nation's roads and highways. We get fooled into

thinking driving is "no big deal" because we do it so often but statistics prove otherwise. Over 100 people will die today on our nation's highways so it is relevant to take our margin discussion to the seemingly simple

act of driving. The most dramatic way to give up our entire margin is to get behind the wheel while under the influence of alcohol or other substances, whereby 35 of those 100 deaths today are attributed to driving under the influence. But there are other insidious ways we give up our margin that we must resist. Distracted driving is now a leading cause of injury and death and the cell phone revolution has taken its toll. Heads down text messaging and



e-mailing, both by us and the other drivers on the road, reduce our margin. We must fight the tendency to be lulled into distracted driving because we think driving is "no big deal". A few moments of text messaging may distract us from our ability to steer clear of an accident by reducing our margin to safely evade.

Everyday we make choices on how to conduct ourselves in all

task domains. We frequently do different and dangerous work on the ground and in the air. We also need to recognize the danger associated with seemingly simple tasks like driving. So ask yourself and your teammates "How is your margin today?" It could make the

difference between a good day and a very bad one.



# CABLEVISION DOCUMENTS BASE

A Cablevision film crew visited F.S. Gabreski Airport (ANG) on Jan. 10 to document the lives of Guardsmen from the 106th Rescue Wing. During their visit they interviewed members of the base, focusing mostly on family members who work together.

The crew included production supervisor Eileen Shanahan, producer Lauraliz Montalbano, production assistant Jeanine Licari and cameraman/editor Eric Abram.

Cablevision's intent is to use the collected footage to create 3, 4-5 minute segments to appear on the TV show, Neighborhood

Journal. The first segment is scheduled to air on January 30, the second on Feb. 20, and the third in mid-March. The show will appear on channel 118 in Suffolk County, and channel 18 in Nassau County. The program will broadcast several times during the week. Cablevision subscribers will also be able to view the program via the video on demand's local section.

Master Sgt. Richard J. Lochren, Recruiting Supervisor, helped manage the film crew as they toured the base. The film crew visited the Medical Clinic, Communications Squadron, Parachute Shop and also observed the Student Flight during their training. Master Sgt. Lochren said the Cablevision visit should help spur the recruiting effort stating that "I think they were able to showcase the search and rescue mission, but I also think they will be able to show that it takes about 1,100 people to make it all come together. You don't necessarily have to jump out of a plane to help contribute to the rescue mission."

# NCDA Rice Speaks at V

On Jan. 10, in the newly painted Hangar B, the 106th Rescue Wing held a presentation ceremony to recognize the hard work and achievements of its members. In attendance was Nassau County District Attorney Kathleen Rice who was recently on the CBS television show “60 Minutes,” highlighting her aggressive DWI prosecution policy she established in Nassau County.

The 106th Rescue Wing’s Commander, Col. Michael F. Canders welcomed and thanked District Attorney Rice for reducing the risk on the road for all of us by aggressively prosecuting DWIs. In addition to the presentation ceremony, the 106th conducted a safety stand-down during the

January drill which focused on addressing many safety issues for the 106th and included the hazards its members face every day on the public roads in their vehicles.

“My goal is to save lives,” DA Rice said to the 106th. “I think too many people view DWI accidents as just another accident,” explained DA Rice, “cars are weapons when put in control of people under the influence of alcohol.”

DA Rice was elected as Nassau County’s District Attorney on Nov. 8, 2005 and took office on Jan. 1, 2006 as Long Island’s first female District Attorney. DA Rice’s office obtained a conviction for two counts of 2nd Degree Murder for an intoxicated driver during a fatal motor vehicle accident that

happened on the Meadowbrook Parkway in July 2005. In addition to a strict DWI prosecution policy, DA Rice also helps to keep our roads safe by establishing a drivers’ safety program that teaches high school students the inherent dangers associated with driving.

Amongst the 106th members who received recognition during the ceremony were the recruiters from the 106th’s recruiting section. They received Air Force Commendation Medals for their recruiting achievements. Compared to 2007, the 106th recruiting team increased their performance rate by 135% in 2008.

Retired Master Sgt. Warneford M. Varlack was recognized for his 27 years of service. “They went good,

## World TB Day


World TB (Tuberculosis) Day is March 24. This annual event commemorates the date in 1882 when Dr. Robert Koch announced his discovery of *M. tuberculosis*, the bacteria that causes TB.

TB is spread through the air from one person to another. TB germs are passed through the air when someone who is sick with TB of the lungs or throat coughs, speaks, laughs, sings, or sneezes. Anyone near the sick person can breathe TB germs into their lungs. TB germs can live in the body without causing sickness and is called latent TB infection. This means inactive (sleeping) TB germs in the body. The inactive germs cannot be passed on to anyone else. However, if these germs wake up or become active in body and multiply, one will get sick with TB disease. When

TB germs are active (multiplying in body), this is called TB. These germs usually attack the lungs. They can also attack other parts of the body, such as, the kidneys, brain, or spine. Active TB will make the person sick. People with TB may spread the germs to people they spend time with every day.

TB can be detected by a skin test or special TB blood test and is a treatable disease. It takes at least six months to one year to kill all the TB

germs. People who are more likely to get sick from TB include people with HIV infection, illegal drug users, babies and young children, elderly, people who were not treated correctly for TB in the past, and people with certain medical conditions such as diabetes, certain types of cancer, or those who are underweight. TB can be prevented by reducing exposure to people sick with TB. BCG vaccine is also available for TB prevention.



## Another Drug Trafficking Organization Shut Down

The Office of the United States Attorney Eastern District of New York, Long Island Criminal Division, honored Master Sgt. Doris Libby, and members of various Law Enforcement Agencies, on Dec. 8, with an annual awards presentation for their hard work in shutting down a major Drug Trafficking and Distribution Operation.

Master Sgt. Libby, is a member of the 106th Rescue Wing and also works with the New York National Guard Counterdrug Task Force, New York City Region, as a Criminal Analyst.

The National Guard Counterdrug program is made up of members from the New York Army and Air National Guard.

The case in question was part of the US Attorney's Office Career Dealer Initiative (CDI), an effort to target long-time, major drug dealers on Long Island. The case involved Peter Zuccaro, an associate of the Gambino organized crime family of La Cosa Nostra, and associates, who

operated a series of marijuana "grow" operations in homes throughout the Brooklyn, Queens and Long Island areas for over a decade. They

eventually consolidated operations into two adjoining warehouses, located less than 100 feet from a New York City grammar school. The warehouse contained a sophisticated indoor hydroponics marijuana "grow" that extended the full width of the block and was powered through the theft of \$800,000 of electricity from Consolidated Edison. Zuccaro and his associates produced enough marijuana to yield millions of dollars of income. The bulk of the marijuana was sold to the marijuana distribution network, Cartoon Network.

Master Sgt. Libby provided valuable assistance and expertise in the case, leading to a series of search warrants and more than 20 arrests which shut down Zuccaro's operation and resulted in the convictions of a number of Gambino associates. More than 1360 kilograms of hydroponic marijuana, worth over 3 million dollars, were seized.



The G-RAP program is not open to AGRs or Technicians, however, they can receive time-off awards for recruits they bring into the Wing. Recruiter Assistants

will be paid for non-prior and prior service enlisted accessions. ## Black History Month

Black History Month serves as a tribute, and remembrance, of important people, and events, in the history of African Americans. Black History Month is celebrated annually during the month of February in the United States and Canada, while in the UK it is held in the month of October.

Historian Carter G. Woodson originated the tribute in 1926 as "Negro History Week". Woodson chose the second week of February because it marked the birthdays of two Americans who greatly influenced the lives and social condition of African Americans: former President Abraham Lincoln and abolitionist Frederick Douglass. Woodson also founded the Association for the Study of Negro Life

Throughout history, African Americans have achieved many milestones, in spite of obstacles and barriers. Two of the most recent and publicized achievements occurred November 2, 2008, when Barack H. Obama became the first African American to win a U.S. Presidential election, and on January 20, 2009, when Obama took the oath of office and became the first African American President of the United States. President Obama also became the first Commander-in-Chief of the United States Military of African descent.
