6. Logo items stock- hats on hand, some hirts available- more ordered, Booney hats on order.


New Business:




1. Financial report- \$ 4300.00 as of this date.

5. Alumni newsletter: Newsletter to go out in Feb. or March


New Business:

Old Business:


1. Financial report- \$ 3963.73 as of this date. \$1000.00 is slated for scholarships.
